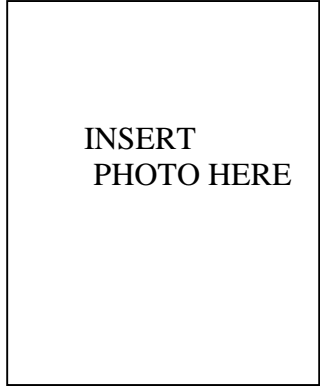

All contestants need to bring a wrap for swimsuit competition. It can be solid or a print. It will be used during swimsuit competition. Pre-Teen Wears Active wear. Something that would be worn to work out.

6. _____ Interview Suit for Mrs. Division. For Pre-Teen, Teen and Miss Divisions there have been changes this year. The interview wardrobe for Teen and Miss are according to Miss Louisiana USA guidelines. They include:
Teen and Pre-Teen: Teens must wear a nice, fitted pair of blue jeans and a dressy top of their choice. Jeans should be nice and free of holes, but can have rhinestones, ribbons, belts, etc. Acceptable tops include jackets, blouses, halters, sweater sets and camisoles. Select heels or boots that compliment your outfit.
Miss: Choose a suit, dress or skirt/slacks/jeans and blouse/sweater in a color and style that compliment our body type and personality. Feel free to select modern stylish pieces that reflect your personality. Do not wear cocktail attire. Select heels and hosiery that compliment your outfit that you choose.
7. Production number is "Paris Runway" we will have a stage that you will do a style show on with Paris fashions. Examples are Gloves, Hats, High Heels and High fashion. Have fun and be creative.
